DECLARATION

In compliance with Article 53 of Law No. 138/2015 of September 7th, it is the Ordem dos Psicólogos Portugueses (OPP) responsibility to exclusively provide the professional title considering the use and practice of the profession in any sector of activity, which is compulsory and depends on the enrollment in the OPP as Full Member.

In compliance with paragraph 1 of Article 54 of the applicable Law 138/2015 of September 7th, can enroll in the Order:

- a) holders of a degree in Psychology awarded on completion of a course of study with internship included realized within the framework of previous studies of organization studies the organization scheme introduced by Decree-Law 74/2006 of 24 March, amended by Decree -Laws Nos 107/2008, of June 25, 230/2009 of 14 September, and 115/2013 of 7 August;
- b) Holders of master's degree in Psychology conferred after an integrated cycle of studies organized master in accordance with paragraph 7 of Article 14 of the Education Law, approved by Law No. 46 / 86 of 14 October, with internship included;
- c) Holders of degrees of Bachelor and Master in Psychology conferred following undergraduate courses of study and master's degree in Psychology with internship included carried out under the organization of studies approved by Decree-Law No. 74/2006, March 24, amended by Decree -Laws Nos 107/2008, of June 25, 230/2009 of 14 September, and 115/2013 of 7 August;
- d) Holders of a foreign academic degree in the field of psychology with internship included who has been granted equivalence to one of the degrees referred to in the preceding paragraphs;
- e) The member states of national professionals from the European Union or the European Economic Area whose professional qualifications have been obtained outside of Portugal, in accordance with Article 62. It is also stated that in compliance with the currently applicable law for the exercise of psychology and use of the title of psychologist, it is required of OPP members to carry out an internship for 12 months, with supervised practice. Therefore the necessary independent parameters to practice Psychology are: hold three years (1st cycle in Psychology) + 2 years (2nd Cycle in Psychology) + 1 year (professional supervised practice in psychology) = 6 years (360 ECTS).

Under the 2nd Article of the Law 9/2009 of March 4th, transposing Directive N°2005/36 / EC (now Directive No. 2013/55 / EU), for the Portuguese reality, the Ordem dos Psicólogos Portugueses is the Competent Authority responsible for the recognition of professional skills in Psychology.

As such, for all intents and purposes, it is stated that **Luis Filipe Grilo De Almeida Viçoso** was accepted as <u>Full Member</u> of the Ordem dos Psicólogos Portugueses, on **July 31th 2012** and therefore holds the **Professional Card No. 13697**, having made proof of detaining the provisions of paragraph **a)** of 54st article of Law 138/2015.

This declaration is valid for six months from the date of issue.
